All vendors must wear shirts and maintain a clean booth area. Trail Days prohibits the sale and/or consumption of alcoholic beverages in the vending areas.

Space is limited to the Richfield City Park, so acceptance of booths will end when capacity is reached. Booths will be accepted on a first paid – first served basis. No vehicles will be allowed to drive on or park on the Richfield City Park without permission from Richfield City. For permission or information, call 435-896-6439.

You must secure your own booth and items inside. Parks will be patrolled at night, but the Richfield Area Chamber and Richfield City will are not responsible for items in your booth or your personal belongings. No vendor may sleep overnight in the park area. Vendors must remove their own trash and debris each day.

Set up will be on Thursday night or Friday morning before noon. All vendors must tear down on Saturday night.

All vendors except those with a Utah State sale tax exemption must collect and pay sales tax to the Utah State Tax Commission. Please use a special event tax form.
